Leisure centre finances may be reviewed

The Peninsula Leisure Centre will be reviewed for operational efficiency if a motion by Cr Jared Wright is adopted at the council meeting tomorrow, Tuesday, February 25.

He will ask that a councillor briefing session be held within three months to "analyse all of Council's income generating assets including Lake Haven Cinema, Peninsula Leisure Centre, Gosford Swimming Pool and Central Coast Stadium".

The briefing session would cover financial performance over 10 years, a cost analysis and viability assessment, community and strategic benefits, relationships with external stakeholders to help run the asset, and any recent undertakings to improve asset performance and draw in additional revenue.

"Ratepayers deserve transparency regarding the use of

their funds and assurance that the Council operates effectively with a solid financial foundation," said Cr Wright.

"A comprehensive review of income generating assets will highlight opportunities for revenue growth and evaluate the feasibility and practicality of retaining these assets and enable well informed decision making going forward.

"Each of these assets presents various opportunities and challenges from a cost-benefit perspective.

"As the Council transitions out of administration, it is crucial to continue evaluating these assets' operational efficiency to secure a robust financial future.

"It remains in the Council's interest to further enhance its financial position to support infrastructure growth, key projects, and ongoing operations."

In a response provided in the meeting agenda, chief executive Mr David Farmer suggested

that two briefings sessions be scheduled.

"It is suggested that the first session provide a high-level overview of the financial performance of these assets over a period, the main drivers of this performance, and the investment in these assets over the same period.

"In this session the various management models, partnerships and any relevant governance aspects will also be covered.

"The Council may wish to identify specific details it wants to obtain, including the high-level aspects of viability, including any scenarios that Council may wish to explore.

"The second session would be focused on delving deeper into the drivers of performance, community and strategic benefits, and the outcome of the scenarios identified during the first session."

"It was pleasing that larger flood and storm debris was not present along the rocky foreshores towards Patonga Headland and across the river at Flint and Steel, Hallots, Hungry and Little Pittwater beaches.

Centre had more small pieces of polystyrene among the old flood timber debris plus a large piece of plastic rainwater tank."

Mr Johnston said the wind and swell made getting in and out of the barge challenging for the volunteers.

Canoe club member Ms Sandi Jeney said: "It is such an awesome experience.

"It makes one feel so good to be doing something so necessary to keep our waterways beautiful."

A load of 180 kilograms of rubbish was dropped off at Woy Woy Tip.

To qualify for publication, articles must have specific relevance to the Peninsula. For example, they must be about activities or events happening on the Peninsula or be organised by or involving Peninsula

The newspaper is not regional or national in nature, so regional or national issues will not be canvassed except as they affect the Peninsula.

Regional sports will only be covered from the perspective of Peninsula clubs. Regional plans will only be aired in the context of their ramifications for the Peninsula.

Peninsula News aims to be inclusive of as much of the Peninsula community as

Readability

To ensure that the newspaper serves its purpose, it must be readable and represent the interests and activities of the community in its content.

Contributions to the paper are edited to consistent standards of readability. Guidelines are available for intending contributors.

All items will be dated. They must contain the name of the author to whom the contribution may be attributed, with their first name spelt out, along with their suburb or organisation. Anonymous contributions will not be accepted.

Forum letters

The Forum section provides the opportunity for readers to express their views on any aspect of Peninsula community life, with the aim of reflecting the community's diversity of opinion

Nevertheless, letters may be edited for readability, including for length, spelling and grammar, and to avoid legal liability on the part of the newspaper, or they may be declined altogether.

Contributors are asked to keep their contributions to the matter at hand, and to focus on the issues and not abuse or insult

Other than in the case of holding public figures to account, criticism of others (as opposed to criticism of particular opinions) is unlikely to be published in the interests of facilitating the expression of a diversity

All letter writers need to supply name, address and contact details. Only name and suburb will be published.

Below average rainfall for February


The Peninsula has received only 40 per cent of its average February rainfall by last Friday morning, February 21.

The total rainfall for February stood at 60.9mm, compared to the month's 20-year average of 155mm, according to figures supplied by Mr Jim Morrison of Umina.

The majority of this, 43.6mm, was recorded on just one day, Tuesday, February 11.

While the January total was almost 50 per cent more than average, the cumulative total for the year was 239.1mm, 13.1 per cent less than the average at the end of February of 275mm.

While January had 20 days with rain, February has had only eight days so far.

Affordable housing delay due to 'unowned' land

An affordable housing development at 18 Macleay Ave, Woy Woy, may be delayed by up to a year after the discovery that part of the land is unowned.

While implementing an agreement to close public pathways along the side boundaries to consolidate them with the land to be developed by Pacific Link Housing, council staff have found "part of the land has no nominal owner", according to a report to Central Coast Council.

A report in a July 2021 council agenda stated that the land at 18 Macleay Ave was owned by the NSW Land and Housing Corporation until 2019, when it was sold to the owner from which Pacific Link Housing bought it.

A report in a October 2022 council agenda states: "The land was zoned RE1 Public Recreation under the Gosford Local Environmental Plan, even though the land is in private ownership."

That report claimed council staff could not determine "why this privately-owned land was zoned RE1 Public Recreation".

No council report since the original rezoning proposal has explained how and why the land was originally zoned for recreation, nor the process by which it came into private ownership, or why the public pathways were created.

The report in tomorrow's Council agenda states: "Historical omissions from State Land Register have been identified after further due diligence (in essence, part of land has no nominal owner).

"Rectification will be coordinated by agents for the owner of the adjoining land.

"This is an inherently lengthy process involving multiple State agencies and Council business units.

"Accordingly full completion must be substantially delayed.

"In the meantime, partial implementation of the agreement will be progressed to achieve an optimal planning outcome."

The target completion date for the project has been delayed by a year to March 31 next year.

Fire service issues battery warning

Fire and Rescue NSW has issued a warning about the use of lithium-ion batteries after a house fire at Umina last week.

Three fire trucks and 12 firefighters were called to the home on Gwendolen Ave shortly after 4:30am on Monday, February 17.

The fire left a man seriously injured with burns and two others suffering from smoke inhalation.

FRNSW Superintendent Adam Dewberry said this was an example of how dangerous lithiumion batteries can be if not used correctly.

"Lithium-ion batteries are a great convenience but if not treated with respect, particularly with e-bikes and e-scooters, they can be extremely dangerous," he said.

"They can ignite with explosive

force, issuing toxic gas, and causing intense fires that spread

"If a fire involving a lithium-ion battery occurs, it literally becomes an explosive device."

Supt Dewberry advised residents never to sleep or leave home with lithium-battery-powered devices charging

"Don't leave them constantly on charge," he said.

On arrival at the fire, crews found smoke issuing from the townhouse and quickly got to work to extinguish the blaze.

The fire was contained within 30 minutes and firefighters conducted a search and rescue operation to ensure no other occupants were in the property.

Fire crews provided emergency medical treatment to three people until NSW Ambulance arrived.

The man suffering burns was

airlifted to Royal North Shore Hospital while the two other people were transported by road.

Investigators believe that lithium-ion batteries exploded, which ignited the blaze.

The batteries were submerged in water to prevent reignition.

The blaze was the second for the Umina 340 station crew for the night.

At about 11.20pm the previous night, crews were called to Bowden Rd at Woy Woy to a fire in a residential complex.

One unit was well alight with multiple explosions reported.

Crews quickly gained control, however the unit was completely destroyed.

All residents had evacuated with no reported injuries.

The wild rabbit control program will be in Umina, as well as five other locations on the Central Coast and other areas in the Greater Sydney area.

Led by Greater Sydney Local Land Services, Central Coast Council issued a media release stating that it would be participating in the program to release the rabbit haemorrhagic disease virus (RHDV1-K5) — also known as calicivirus.

Residents told to vaccinate pet rabbits

"Wild rabbits are Australia's most destructive agricultural pest, causing severe competition for resources and land degradation," said Central Coast Council chief executive Mr David Farmer.

"Council strongly advises pet rabbit owners to vaccinate their rabbits by 1 March 2025. "Pet rabbit owners should also take extra precautions, including maintaining good hygiene, providing mosquito-proof housing and preventing contact with other rabbits."

Tree canopy limit could be 15 per cent

The construction of a new dwelling at 40 Patonga Dr, Patonga, would see 15 native trees felled and tree canopy cover limited to 15 per cent, if fire report recommendations are followed.

The development application lodged with Central Coast Council is for a three-bedroom dwelling with an attached garage in "a designated bushfire-prone area" and includes the demolition of an existing structure.

The block has an area of 487.5 square metres, is zoned R2 Low Density Residential and slopes steeply down from the road towards the rear.

The application, prepared by Barker Ryan Stewart, states that the driveway has been designed with an elevated portion to "ensure practical vehicle access", given the slope of the site.

The proposed front setback is 0.5 metres, which does not comply with the required 4.5m front setback of the planning provisions.

The application claims that this variation is supportable because the design is consistent with other residential developments in the area, where garages or parking areas are in close proximity to the road due to the slope.

Otherwise, the application



states that the proposal is generally compliant with relevant State and Central planning provisions.

A flora and fauna report, prepared by Mcivor Environmental, determined that the proposal was unlikely to result in significant impacts on any threatened species, populations, or communities.

It did not identify any threatened flora or fauna species, or migratory birds, within the study area.

An arborist report, prepared by Naturally Trees, stated that the proposed development would result in the removal of 15 native trees.

Nine native trees are to be retained on the site.

A bushfire assessment report, produced by Clarke Dowdle and Associates, recommends that the

proposed dwelling be constructed to "bushfire attack level - flame zone" requirements "and requires referral to the Rural Fire Service.

The report recommends that "the entire site be managed as an Inner Protection Area", one of the requirements being that tree canopy is to be no more that 15 per cent at maturity.

It also recommends shrubs account for no more than 10 per cent of site cover and grass be kept mown on the remaining 38 per cent of the site not covered by the building.

The application is currently on public exhibition but the Council website gives no closing date for submissions.

McWaide calls for exemption for events on council land

West Ward Councillor Trent McWaide will move for a "simplified development approval pathway for events" at the council meeting tomorrow, Tuesday, February 25.

He will ask the council to prepare an event strategy "which would exempt temporary events on Council land from the requirement for development consent".

"Similar provisions were previously included in the Gosford Local Environmental Plan but removed from the Central Coast Local Environment Plan upon its

adoptior

"Such events would be controlled under the existing requirement for operators to gain approval for use of Council land under the provisions of the Local Government Act."

Cr McWaide said events were important to the region "in both economic and social terms".

His motion will ask for an event strategy to be drafted "for the purpose of increasing events for the Central Coast and establishing a range of actions to work towards that purpose".

Four certificates issued for complying dual occupancies

Complying development certificates have been around for a while on the Peninsula, but until now they have been for single dwellings.

In the last few weeks four dual occupancy certificates have been "completed", which means they were issued.

There are two in Umina, at 25 Donald Ave and 28 Osborne Ave, and two in Ettalong, at 139 Broken Bay Rd and 104 Barrenjoey Rd.

Neighbours may have been

development notified by a generous owner in advance.

Otherwise, under the planning rules, neighbours are entitled to just two days' notice before construction commences.

Even then plans are not available.

Neighbours certainly won't have any formal opportunity to raise concerns

Two-storey house would lose 19 trees

An application has been lodged for a five-bedroom two-storey house at 42 Beryl Boulevard, Pearl Beach, which would see the removal of 19 trees.

The 676.6 square metre R2 low density residential zone site is vacant and is located within a coastal environment area, also mapped as bushfire-prone land.

It previously contained a dwelling that has since been demolished.

The house will have living areas on both levels, and an attached double garage.


The application claims the proposed architectural styling complements the character displayed by development throughout the locality.

The application admits the house is not compliant with front setback requirements.

It acknowledges a front balcony, supported by substantial columns, has just 2.93 metres setback, but claims this is an "articulated element" that is in front of the building line from which the setup should be measured.

The application claims the setback of the "main building line" is 4.93 metres, while the planning provisions require a setback of greater than six metres.

The application also admits an "articulated element" should be



the site and less than 1.5 metres deep.

The balcony is 5.895 metres wide or 38.7 per cent of the site width, and two metres deep.

Columns supporting the balcony and a roof

The application states the rear deck displays is being counted as private open space, but is an area of 14.37 square metres, less than the prescribed standard of 24 square metres.

According to an arborist report, a total of 19 trees will need to be removed.

Five trees are located within the footprint of the proposed development.

Nine trees will encroach upon it. Another five trees have no encroachment but are proposed for removal as part of the development application.

There are 11 trees to be retained.

A fire report states that the site is within a bushfire risk zone and that "the proposed works are subject to BAL 29 and therefore requires referral to the Rural Fire Service".

Masonry retaining walls are proposed with side setbacks greater than one metre.

An estimated 191 cubic metres of excavation material will be removed from the site.

The application is currently on exhibition but the closing date for submissions has not been disclosed on the council website.

Proposal to convert restaurant into dwelling

The conversion of a restaurant into a dwelling house has been proposed for 1/471 Ocean Beach Rd, Umina.

The application states the building was originally a corner shop, colloquially known in the 1980s as The Halfway Shop, halfway between the beach and the town centre.

The proposal involves converting the single-storey rendered brick and weatherboard restaurant into a residential dwelling and demolishing a detached garage-shed to construct a new garage and covered rear deck.

The external appearance of the building would remain substantially the same, with only minimal changes, the application states.

A large covered deck will replace a service area at the rear, the building will be re-clad and the windows replaced to complement

the streetscape while maintaining its original "corner-shop" character.

The dwelling house would include four bedrooms, and open kitchen, living and dining areas.

The application states that

retaining the existing building is in the public interest, because it preserves the heritage aspect of the corner site, which has housed a shop for about 50 years.

The alternative, it is claimed, could be a two-storey development with a greater floor area, resulting in an inferior outcome for neighbouring sites and the streetscape.

The application claims that the proposal would not remove landscaping from the lot and the site includes street trees.

The application is currently on public exhibition and is open for written submissions until March

Neal calls for councillor motion limit to be removed

West Ward Councillor Belinda Neal will seek to remove the limit on the number of motions a councillor can make at a council meeting.

The Central Coast West Ward covers the Peninsula.

Cr Neal will ask the council meeting tomorrow, Tuesday, February 25, to amend the council's code of meeting practice to remove the restriction limiting councillors to one notice of motion at each council meeting.

She will move that the code allow councillors to submit multiple motions per meeting "provided they comply with the established rules and procedures, including deadlines and content requirements".

She will move that " meeting agendas continue to be managed effectively to maintain meeting efficiency and ensure that all councillors' motions are given adequate time for discussion".

However, in a response included in the agenda, chief executive officer Mr David Farmer has opposed the move.

"In high performing councils, the use of Notices of Motion to allocate resources to activities is minimised through effective forward planning and prioritisation.

"In addition to the community, councillors have been active in guiding the development of the draft Community Strategic Plan, Delivery Program and Operational Plan which is the appropriate mechanism to reprioritise particular activities and services."

Mr Farmer said: "A limit on the number of Notices of Motion places strategic planning into focus and also enables suitable allocation of time to respond to a small number of otherwise unavoidable motions."

He said the Local Government Act required the councillors to "focus on strategy, policy and financial sustainability".

He said it stated: "Councils should plan strategically, using the integrated planning and reporting framework, for the provision of effective and efficient services and regulation to meet the diverse needs of the local community."

Mr Farmer said: "Council substantially undertakes this role through the "integrated planning and reporting" suite of documents.

"These set the long, medium and short term focus of Council.

"These plans are supported by the resourcing strategy which allocates assets, staff and budget to specific work programs.

"The most efficient way to allocate funds or resources to a particular activity is through the Operational Plan and budget.

"Almost all Notices of Motion result in resource reallocation if not additional allocation.

"For this reason, it is important that Council has the opportunity to consider the implications of any Notice of Motion.

"To enable that information to be gathered for inclusion in the business paper, sufficient time must be allocated."

Creek regeneration needed, says ACF group

The Central Coast branch of the Australian Conservation Foundation has called on Central Coast Council to increase funding for bush regeneration of riparian zones from Correa Bay to Mt Ettalong.

It has also asked the council to consider buyback of flood-prone property.

The call follows the release last week of a report by the Australian Housing and Urban Research Institute entitled Integrating Housing Policy, Settlement Planning and Disaster Management.

The report has found that governments need to map land due for retreat and develop a database of land suitable for resettlement, according to the ACF group convenor Mr Mark Ellis.

He said the council's most recent flood report suggested education around the issue of flooding but ignored the indicators affecting the Kahibah Creek and Iluka Lagoon.

"Property buyback was not



mentioned even though the area is surrounded by high-risk residential property exposed to rising sea levels and storm surges," he said.

"With recent flash flooding on the Peninsula, the question is: What are the council and State Government doing to adapt the surrounding residential areas to the issue of flooding from extreme weather and to address the riparian zones of the Peninsula, which are either choked by weed growth or suffering eroding the banks."

Mr Ellis said bush regeneration was needed in these areas, which

include Kahibah Creek and its tributaries, to better prepare for increased rainfall and floods due to climate change.

He said that one of the authors RMIT University researcher Dr Annette Kroen recently stated that many long-term residents were unaware of future risks.

"Instead, they assess risk based on previous experience not the increasing risk from climate change impacts."

Nobody will be happy with Ettalong changes

Norm Harris asks ("What community?", PN а 612) whether high-rise development at Ettalong would add to the Peninsula's social character, and the answer is that, of course, it would.

The Peninsula has always been changing, ever since the first unmade roads allowed holiday shacks to be built in proximity to the beach.

No doubt, those owners thought that the place was just as it should be and that its character should not be changed.

However, there was nothing finished or perfect about the Peninsula then and there is nothing immutable about the Peninsula today.

It is adapting to new desires and new people, just as any community has to, if it doesn't want to just curl up and die.

We need to add to the Peninsula's social character, and part of this change will be to provide for the kind of households that want to live in high-rise buildings.

We have already seen many transitions in the numbers and types of households who live on the Peninsula and in the kinds of accommodation they want.

Now, we have to accept the fact that there will be new people with new wishes in the future, and that they have just as much right to be here and to be properly housed as do the oldest inhabitants.

The important thing is that whatever changes are needed be

introduced in a way that preserves the best of the existing community and enhances the variety of the urbanscape for old and new.

Unfortunately, it is easy to predict, just from looking at the shambles being created in Ettalong now, that the opposite will happen.

The pathetic inadequacy of the development controls adopted by the Council is only matched by the desperate lack of imagination among developers whose only interest is the maximum profit that can be wrung from a property.

While the Council was in administration, there was much talk about the need for new thinking about our development goals, but, when the community was given the option, it elected the same old tired hacks who drove the Council into administration in the first place.

We now seem to have a Council hell-bent on development at any cost and with minimum participation by ratepayers in any of the decision-making process.

So, the obvious answer to Norm Harris's question is that Ettalong will be changed and it will be changed in the clumsiest possible way, so that nobody is happy with the results, except the speculators who have made a good thing out of a complaisant Council and an electorate that is, apparently, quite happy that this is as it should be.

It is puzzling that Central Coast residents seem so satisfied to live in a sub-optimal environment, when there was the opportunity for it to be so much better.

Horsfield Bay studio and garage plan

A second dwelling, a studio, garage and carport are proposed to be built at 14 Horsfield Rd, Horsfield Bay.

The redevelopment aims to reduce the steep gradient of the drive, to relocate the garage onto the south-east boundary, creating an area for a lightweight timber car parking platform on the north-west.

"In the Gosford electorate, vacancies dropped by 64 per cent," she said.

"As a former school teacher, I understand first-hand the amazing influence that teachers have on children's lives.

"Having a qualified teacher at the front of every classroom is vital to delivering improved academic outcomes for students.

"We want teachers to return to

the front of our classrooms doing what they do best.

"We know there's more to do, but this is a fantastic announcement that shows that the work the Labor Government is doing is working."

She said that state-wide there was a 40 per cent reduction in vacancies since the same time in 2023 before the Labor Government came into office and the lowest number of vacancies at the start of a school year since 2021.


